The 2010 CAS Annual Meeting will be hosted by the C.T. Hurst Chapter in Gunnison on October 1-3.

The registration fee includes coffee/tea all day Saturday, plus morning and afternoon snacks. The Saturday Banquet is not included in the registration fee.

The Saturday evening Banquet is a buffet, with two entrees: roasted pork and dressing, and portabella ravioli. Other dishes include roasted red potatoes, green beans almondine, and two salads. Desserts are peach cobbler with ice cream, and chocolate mousse. Bread/rolls and beverages are included.

## CAS Quarterly Board Meeting Highlights

Cortez, Colorado, July 24, 2010

The Quarterly Board meeting of the Colorado Archaeological Society was called to order by Vice President Linda Seyfert on July 24, 2010 in the Anasazi Heritage Center in Dolores, CO. Chapters represented were: Chipeta, Denver, Hisatsinom, Indian Peaks, Pikes Peak, Pueblo, Rock Art, San Juan Basin, and Vermillion.

### TREASURER:

Michele Giometti submitted the Balance Sheet, Statement of Revenues, Expenditures and Change in Fund Balance for the Second Quarter, 2010. Current assets are \$39,508.13 and liabilities are \$3,000.00.

### MEMBERSHIP:

There are 1,104 chapter members and 799 chapter memberships. Unaffiliated members are 68 and unaffiliated memberships are 59.

### ALICE HAMILTON SCHOLARSHIP:

No big items have been offered for the 2010 Alice Hamilton Raffle. Therefore, the Pinasco Blanco painting from the 2006 raffle will be raffled in 2010 as the Alice Hamilton Scholarship fundraiser. The Pinasco Blanco painting originally was won in 2006 by Don Nordstrom, but his estate donated the painting back to CAS after Don's passing. Because of the delay in selecting an item to be auctioned, the Alice Hamilton fundraising auction will be held later than usual in 2010. Publicity will begin in August. Raffle tickets sale will be in September through November. Drawing will be held in December. The 2011 Alice Hamilton Scholarship fundraiser will be an archaeology trip.

### PAAC:

The Summer Training Survey was conducted on July 7-14 at Antelope Gulch. Eighteen volunteers participated in the survey. Participants by chapter were: Pikes Peak (4), Denver (3), Indian Peaks (3), Northern Colorado (2), Pueblo (1), Roaring Fork (1), and unaffiliated (3). Aaron Theis (OAHP) assisted by supervising a crew of 4-5 volunteers on 6 days. It is planned to return to Antelope Gulch for the 2011 PAAC Summer Training Session. The new schedule for PAAC classes during the second half of 2010 was posted on the OAHP website.

### PUBLICATIONS / SOUTHWESTERN LORE :

The Spring issue of Southwestern Lore (76:1) was a commemorative issue for the 75th Anniversary of CAS. The Summer issue is completed and is set for a printing date of August 29. Bruce Bradley has agreed to be Assistant Editor of Southwestern Lore.

### PUBLICATIONS / SURVEYOR NEWSLETTER :

Joel Hurmence is stepping down as Surveyor Newsletter editor and Publications Chair after the next issue. New chairs are needed.

### PUBLICATIONS / WEBSITE:

The new CAS website is up and running.

### ADVISORY BOARD:

Second quarter reports on each chapter's archaeological activities were presented by Linda Seyfert. Reports were received from Chipeta, Denver, Hisatsinom, Indian Peaks, Pikes Peak, Pueblo, Rock Art, San Juan Basin, and Vermillion chapters. The reports will be combined into a final report to be published in the Surveyor.

### AWARDS:

Chapters are requested to submit nominations to Jason LaBelle for Ivole Hagar, C. T. Hurst, and chapter awards to be presented at the October 2010 CAS Annual meeting.

### EDUCATION/COMMUNITY OUTREACH:

The Eagle Scout project leader has selected three Eagle Scout candidates from his Sedalia chapter to assist with the two programs (anti-vandalism and Archaeology Merit Badge). Over 1000 pictures were taken in the Grand Gulch area in June. Work is under way on the anti-vandalism Power Point presentation.

Terry Murphy issued a challenge. If three CAS chapters train Boy Scout leaders within three years, Terry will make a donation to the CAS education fund. Chapters putting on training classes for the Boy Scouts themselves will not count towards the challenge.

## **CAS Advisory Board to the State Archaeologist**

2ND Quarter, July 24, 2010

### **ARCHAEOLOGICAL ACTIVITY SUMMARY REPORTS**

#### **Scientific (Survey, Testing, Excavation, Lab):**

**Denver** - Work continues at Blackfoot Cave and curation of artifacts from the excavation. We have four new 1x1 m grids open and have or are closing 3 grids. Two of the new grids are producing a relatively large number of prehistoric artifacts including many sherds, a chopper, a couple of nice cores and at least one late prehistoric projectile point. We are still looking for evidence of earlier occupation. In another grid started last season a trade bead dating to the early to mid 1800's was found. The first artifact from the time period the Cherokee Trail was in use. We had one day of survey at W. Bijou so far this year and found and recorded a nice site which included a late Paleoindian point. We will stop Blackfoot excavation early in the fall and concentrate on survey at W. Bijou for the remainder of the season. We also plan to start a site formation study at W. Bijou that will continue for several seasons. The study will help us understand how artifacts move and are exposed and covered over time at sites in two or three different topologies at W. Bijou.

**Hisatsinom** - Mitchell Springs Great Kiva excavation season opened, to extract burned roof beam that were discovered to lie underneath the kiva floor. Once removed, we will be excavating and evaluating the possibility that the burned structure is a pit house. In order to get a more complete picture of the network of

Great Houses in proximity to Mitchell Springs, members have been surveying sections 11 & 12, in search of a "lost" ruin cited in early 1900 docs, but whose location is unknown. The area is located at the northern base of the Mesa Verde escarpment. The land is now owned by BLM and private landowner. Our results will be shared with the BLM. A recent day resulted in locating 9 habitation sites, including a Great Kiva.

**Pikes Peak** – At the request of Barr Camp and US Forest Service, PPC did an archaeological survey and a complete building inventory of historic Barr Camp on the east slope of Pikes Peak June 30. The process of completing forms, maps, and photo logs are now in progress. The survey will allow some restoration of the site.

**Vermillion** - On June 20 and 21, two members of Vermillion Chapter assisted Geoff Haymes, Archaeologist for White River BLM Office in photographing the interaction of shadows on Sun Dagger Site at East Four Mile Site in Canyon Pintado. Vermillion Chapter has agreed to assist White River BLM in doing assessments for site evaluations for grazing leases and updating site forms in Canyon Pintado. On June 20, two members completed evaluation for two sites in Canyon Pintado. On June 21, five members completed evaluation for one site in Canyon Pintado.

### **Publications/Reports:**

**Denver** - The Swallow Site report is slowly progressing.

**Hisatsinom** - Report on the Galen Larsen property survey (2008-09) will be published in SWL next issue.

### **Curation Issues:**

**Denver** - We are fortunate to have curation of Blackfoot Cave material at the Douglas County repository, a state certified curation center for all historic and prehistoric artifacts from Douglas County. We also have a curation agreement with Denver Museum of Nature and Science for artifacts that might be curated from W. Bijou. However, there is in general a "no curation" policy at W. Bijou during survey. That will change if we start testing in 2011.

### **Site Stewardship:**

**Chipeta** – 4 completed stewardships involving 9 members.

**Hisatsinom** - Continuing... Member Diane McBride is now the site-steward coordinator of Cyn of Ancients NM sites for San Juan Mtns Assoc. program.

**Pueblo** - Eight chapter members attended training for the South East Colorado Cultural Site Stewardship Program in LaJunta March 13th.

**San Juan Basin** – A few members are site stewards in the program managed by the San Juan Mountains Assoc. Stewards monitor sites at least once a quarter. Some sites are monitored monthly, depending on expected site impact.

### **Vandalism and Compliance Issues:**

**San Juan Basin** – Cultural site stewards notify the appropriate Federal or State agencies if any vandalism is observed. None was observed during the last quarter.

### **Cross-Organization Interactions:**

**Chipeta** – Montrose Summer Youth Outreach Program "Ruins and Rock Art".

**Denver** - We have been fortunate to have great participation by the Douglas County Historic group at Blackfoot Cave. They have generally provided as many volunteers as the Denver Chapter of CAS and their research of the historic past of the site has been very useful and informative. Due to a lack of volunteers, Denver Chapter's rock art presentations to school groups were not active in the spring. Sessions have been scheduled this fall at 2 elementary schools in Denver.

**Pikes Peak** – The group's annual picnic was held at the Mining Museum with tours of displays.

**Pueblo** - Karen Clouse announced a Pit Program with Al Kane.

**San Juan Basin** – Several members helped to construct a trail in Ute Mountain Park under the direction of a Ute Mountain Park ranger. Ten members are assisting at Pecos Conference to be held in Silverton.

### **Public Education/Outreach:**

**Chipeta** – 15 members toured paleontological sites with BLM/CAS

**Denver** - At the request of the Forest Service archaeologist on a New Mexico Passport in Time (PIT) project, President Bob Rushforth gave a talk on aviation archaeology ethics to a group in Gallup, NM.

**Hisatsinom** - May Preservation month speaker was Cindy Bradley, reporting on her thesis research on Mortuary Practices at Wallace Ruin (Cortez).

**Pikes Peak**- PPC was invited to participate in the Founder's Day celebration in Old Colorado City. The chapter will be showcasing its programs and activities Aug. 14th. Steven Veatch, PPC member and a research geoscientist, led 35 members on an evening tour and history orientation of the newest Colorado Springs Park, Red Rock Canyon Open Space, May 25. He gave each attendee a still-in-editing version of his new field guide to the park and its history. He will do the same at Florissant Fossil Bed Aug. 7.

**Pueblo** - The Rock Art trunk was presented to elementary students in April.

**San Juan Basin** – Several members participate in the volunteer program at Mesa Verde. Several members volunteer at the Anasazi Heritage Center on a regular basis. Several members assist on a weekly basis with curation efforts for the artifact collections at the Center of Southwest Studies. Joint meetings are held with the Life Long Learning Program and Center of Southwest Studies of Fort Lewis College several times a year. Our monthly meetings normally draw 40-60.

**Indian Peaks** – Boy Scout fair, April 2010

## CAS Annual Meeting Banquet Speaker: Mark Varien

### Topic: Update on Southwest Pueblo Archaeology

Dr. Mark D. Varien is Vice President of Programs at the Crow Canyon Archaeological Center in Cortez, Colorado. Varien joined the staff at Crow Canyon in 1987, where he contributes to the Center's mission to conduct archaeological research, provide public education programs, and promote American Indian involvement in archaeological research and public education.

He has been a professional archaeologist since 1976, conducting fieldwork in Guatemala, New Zealand, Texas, Oklahoma, Colorado, New Mexico, Arizona, Washington, Idaho, Montana, and Oregon. He served as a crew chief for the Dolores Archaeological Project in southwestern Colorado and as a project director for the Zuni Archaeology Program, a Zuni Indian tribal enterprise in Zuni, New Mexico.

At Crow Canyon he directed the Sand Canyon Archaeological Project Site Testing Program, which led to numerous publications. He received a B.A. in Archaeological Studies (1976 University of Texas, Austin), a M. A. in Anthropology (1984 University of Texas, Austin), and a Ph.D. in Anthropology (1997 Arizona State University).



His current professional interests include the archaeology of the southwestern United States, site formation processes, household and community organization, patterns of sedentism and mobility, settlement patterns and the formation of cultural landscapes, human impact on the environment, social theory, public education programs about archaeology, and Native American involvement in archaeology.

of Trincheras Cave. The Loudens were instrumental in the establishment of the Loudens-Henritze Archaeology Museum at Trinidad State Junior College. Wolf Spider Shelter (5LA6197) - near Trincheras Creek. Excavated by O. D. Hand and Daniel A. Jepsen, the site was inhabited on a temporary basis on numerous occasions spanning several thousand years. Activities included stone and bone tool manufacture, flora and faunal processing and perhaps storage. The manufacture of decorative bone beads and shell pendants as well as the presence of a delicate ground and shaped paint

palette suggests leisure, ritual or strictly ornamental activities.

**Rock Art** – The chapter had a successful annual meeting May 15th at Trinidad State Junior College.

**Pikes Peak**- The chapter currently has a total of 86 memberships and 120 members.

**San Juan Basin** – There were 4 trips during the first quarter and 8 trips in the 2nd quarter of 2010. These trips included visits to New Mexico, Arizona, Utah, in addition to local trips in Colorado.

**Vermillion** - Vermillion Chapter has finalized the grants from the Colorado Historical Society in the amount of \$89,503.00 and \$29,470 from the BLM for a study of Sand Wash quarry sites in cooperation with the Little Snake River BLM. The contract for this project was awarded to Alpine Archaeological Consultants, Inc. of Montrose, Colorado to conduct these surveys.

The well-known ruin depicted is located in Chaco Canyon National Historic Park in NW New Mexico. Peñasco Blanco is an unexcavated great house, built concurrently with Pueblo Bonito and Una Vida, unique in design (oval), and connected to several Chacoan roads to the west. This light-filled work measures 11'x14", mounted in a gold leaf carved frame. Mr. Montgomery is a well-known artist of the San Luis Valley and Southwest open air spaces, landscapes, ruins and rock art. His bio sketch is attached.

This work of art was originally donated by Ms. Gayle Andresen, Denver.
